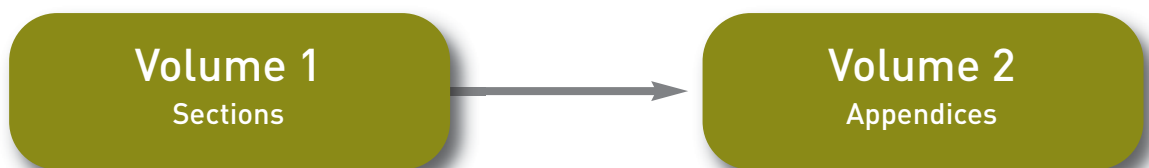
User Guide

An Environmental Impact Statement (EIS) was completed for the Alpha Coal Project (a proposed 30 Mpta open cut thermal coal mine and rail and port infrastructure facilities) and made available for public comment from 5 November 2010 to 20 December 2010 (Issue 3, November 2010). The EIS covered potential environmental issues related to the development and operation of the Alpha Coal Project and how they would be managed.

The Alpha Coal Project Supplementary Environmental Impact Statement (SEIS) has been prepared in response to the submissions made during the public comment period and changes to the Project Description following the release of the EIS.

The SEIS is split into two volumes: the first volume covers the Introduction and Project Description changes. It also covers the Project Wide, Coal Mine and Railway Corridor response to the submissions made. Volume two contains the corresponding stand alone technical reports and supporting documentation.
